

**RELEASE, WAIVER OF LIABILITY and INDEMNIFICATION TO NATURAL GUARDIAN OF MINOR CHILD  
PARTICIPATING IN VETERAN'S DAY PARADE NOVEMBER 11, 2024**

**READ THIS FORM COMPLETELY AND CAREFULLY. YOU ARE AGREEING TO LET YOUR MINOR CHILD ENGAGE IN A POTENTIALLY DANGEROUS ACTIVITY. YOU ARE AGREEING THAT, EVEN IF The City of Jacksonville its members, officials, officers, employees and agents AND ANY OF ITS DEPARTMENTS, JACKSONVILLE SHERIFF'S OFFICE AND JACKSONVILLE DEPARTMENT FIRE RESCUE USE REASONABLE CARE IN PROVIDING THIS ACTIVITY, THERE IS A CHANCE YOUR CHILD MAY BE SERIOUSLY INJURED OR KILLED BY PARTICIPATING IN THIS ACTIVITY BECAUSE THERE ARE CERTAIN DANGERS INHERENT IN THE ACTIVITY WHICH CANNOT BE AVOIDED OR ELIMINATED. BY SIGNING THIS FORM YOU, ARE GIVING UP YOUR CHILD'S RIGHT AND YOUR RIGHT TO RECOVER FROM The City of Jacksonville its members, officials, officers, employees and agents IN A LAWSUIT FOR ANY COVID-19 ILLNESS, DEATH, BODILY INJURY OR PROPERTY DAMAGE, TO YOUR CHILD OR ANY PROPERTY DAMAGE THAT RESULTS FROM THE RISKS THAT ARE A NATURAL PART OF THE ACTIVITY. YOU HAVE THE RIGHT TO REFUSE TO SIGN THIS FORM, AND THE CITY OF JACKSONVILLE HAS THE RIGHT TO REFUSE TO LET YOUR CHILD PARTICIPATE IF YOU DO NOT SIGN THIS FORM.**

COVID-19 illness, death, bodily injury or property damage

I, as the natural guardian of, \_\_\_\_\_ a minor, acknowledge that access to City parks and/or streets in connection with participation in 2024 Veteran's Day Parade (the "Activity") may involve risk of serious injury, Covid-19 illness, including permanent disability and death, and severe social and economic losses which might result not only from my minor child's own intentional or negligent acts or omissions, but also from the intentional or negligent acts or omissions of others and from any equipment used in the activity or the condition of the park facility or streets.

To the extent allowed by law, I indemnify, defend, and hold harmless the City of Jacksonville, its members, officials, officers, employees and agents against any claim, action, loss, damage, injury, liability, cost, or expense of every kind or nature including COVID-19 illness, death, bodily injury or property damage to any person(s) arising out of or incidental to any intentional or negligent act or omission on my child's part in connection with access to the Park and/or streets in connection with participation in the Activity. This indemnification is not, and shall not be interpreted as, a waiver by the City of its sovereign immunity under §768.27, Florida Statutes.

To the extent allowed by law, I release, waive, and discharge the City of Jacksonville, its members, officials, officers, employees and agents from any and all liability to me and my child and from any and all claims, losses, or damages of every kind or nature, including, but not limited to, COVID-19 illness, death, bodily injury or property damage arising out of or incidental to my child's access to the park and/or streets in connection with participation in the Activity. The release, waiver, and discharge apply also to my heirs, assigns, and legal representatives.

I understand and agree that my child's access to the park and/or streets in connection with participation in the Activity is completely voluntary, that my child is under no obligation to participate, that I am giving up substantial rights of me and my child by signing this release, and that I sign this release voluntarily.
